Our Payment Scheme

Thereafter, you are expected to pay instalments as specified on our ticket pages towards your outstanding balance by the close of each month starting the following month of your initial payment (If this requirement cannot be met, please inform info@mydubai-vip.com).

Your outstanding balance must be paid in full on or before 1st September 2017. Failure to keep up with your additional payments or meet the final payment deadline may OR will result in additional charges and/or your booking being cancelled.

How to make Payments

All payments will be made via eventcube, therefore all currencies will be accepted and the necessary invoice and receipts will be sent via the email, which has been provided.

Event Cube is the online ticketing platform which we use, to enable us to receive your payments securely.

Refunds

All initial deposits are non-refundable and non-transferable. Up to 50% payments thereafter are refundable until 1st August. From 1st August all payments including your initial deposit will become non-refundable and non-transferable.

How to use discount codes

All discount codes have been accepted by our necessary partnerships. The discount codes will not be available for the full duration of the ticket sales. The discount code will only be available for the limited time stated. Please refer to the latest media advertised.

Please note that your discount will not be applied on your initial deposit payment but instead deducted from your overall total payment of your selected package. This will be reflected on your invoice which will be sent to you via email

Event passes

Please note that your pass will be given to you on arrival, and you must keep your pass with you at all times to get into all events. Not all passes can be used for all events. So please ensure that you are happy with your package and be willing to pay on the door to get into the parties you may not have a pass to get into. There are limited spaces available to pay on the door; therefore entry will operate on a first come first served basis.
